I, the undersigned participant, in consideration of the purchase of the undersigned participant's ticket to WonderLust 2018 (hereinafter referred to as "The Event") to be held September 26-October 3, 2018, do hereby fully and unconditionally release and forever discharge WonderLust LLC, its members, managers and agents, the organizers of The Event and the organizers' heirs, executors, administrators, personal representatives, and attorneys-in-fact, in addition to Spirithaven LLC, and the owners of Spirithaven Farm, J. Scott Eutsler and Kay Horton-Eutsler (hereinafter referred to as "The Landowners"), and their heirs, executors, administrators, personal representatives, attorneys-in-fact, successors and assigns from any and all claims, losses, liabilities, demands, claims against bodily injury and personal injury, actions or causes of action of any kind or character (including, without limitation, for attorneys' fees, costs and expenses) that I may have whether known or unknown, whether in law or in equity, whether in contract, tort or under statute, ordinance or otherwise, on account of, connected with, or arising from my entry and attendance at the WonderLust LLC sponsored event held from September 26th to October 3rd, 2018 at the location known as "Spirithaven Farm", in Patrick Co., Stuart, VA.

I agree to indemnify, hold harmless, and defend WonderLust LLC, Spirithaven LLC, The Landowners, and the organizers of The Event from any claims arising out of or related to my participation in The Event.

I, the undersigned participant, acknowledge and assume that there are certain inherent risks associated with The Event including the presence of lakes, creeks, uneven terrain, rocks, holes, trees, plants and other forest growth, wildlife, fire (including bonfires, campfires and mobile flame vehicles), large interactive art projects and other related hazards. Likewise, I understand and acknowledge that there are risks associated with the activities and behavior of myself and other attendees of The Event, including intoxication, dancing and other revelry.

I acknowledge that my participating in the many varied camping and recreational activities entails both known and unanticipated inherent risks, which include, but are not limited to: exposure to the outdoors, nature, weather, Acts of God, wildlife (bears, raccoons, snakes, etc.), insects, plant life, inexperience or unfamiliarity with the various activities and/or its requirements, unfamiliarity with the location or facility, faulty equipment or gear that I brought with me, acts of other participants (including violent or criminal acts), complications or reactions from weather conditions or outside environment or nature, inadequate or unavailable healthcare facilities or assistance, accidents, illnesses, allergic reactions (to food, insects, etc.), negligence or mistake.

In the event I am unable to provide my actual consent, I hereby consent to receive medical treatment considered advisable in the event of accident, injury or illness during The Event. I understand and agree that agents of The Event are not obligated to provide medical services at any time. I hereby release, indemnify and hold harmless WonderLust LLC, Spirithaven LLC, The Landowners, and any and all agents, representatives or employees of either entity, who may provide aid or medical treatment to me even if such assistance is later determined to be improper, negligent or harmful. I hereby release, indemnify and hold harmless WonderLust LLC, Spirithaven LLC, The Landowners, the organizers, volunteers, and consultants of all its activities from any and all liability in connection with any injury (including any injury caused by negligence).

Further, I, the undersigned participant, acknowledge the location of one lake on the property, and should I undertake and/or participate in any activities located on or within the shoreline, that I assume the risk and/or dangers resulting from my participation in such activities. I acknowledge that during the event held on

September 26-October 3, 2018, that the organizers of The Event shall not hire or provide the services of any lifeguards or boating safety officers to monitor or supervise the activities of any participant on or within the shoreline of the lake. I also understand that any activities in the lake itself, including but not limited to swimming, boating, kayaking, canoeing, flotation, fishing or any other water activity is strictly prohibited and will result in my immediate expulsion and removal from The Event.

It is my intention and desire that this Waiver be construed as broadly as legally possible such that WonderLust LLC ,Spirithaven LLC, The Landowners, and any representatives or volunteers shall NOT be liable for any harm suffered by me as a result of my attending The Event. In the event of controversy, I hereby agree to initiate mediation in Patrick County Virginia at my sole expense as a condition precedent to the filing of any action in a court of law. Should legal action be commenced, the prevailing party shall be entitled to an award of attorney's fees and costs. Damages for any action against WonderLust LLC, Spirithaven LLC, The Landowners, representatives or volunteers shall be limited to the actual cost of entry fees and shall not include foreseeable, unforeseeable or consequential damages. Any dispute shall be resolved in accordance with the laws of the State of Virginia, County of Patrick which is where jurisdiction and venue shall be.

I hereby understand and agree that this General Release, Indemnification and Assumption of the Risk shall be binding upon my heirs, executors, administrators, personal representatives, attorneys-in-fact and collectors and that this General Release, Indemnification and Assumption of the Risk shall inure to the benefit of The Event, WonderLust LLC ,Spirithaven LLC, The Landowners, its organizers, their respective heirs, executors, administrators, personal representatives, attorneys-in-fact and collectors of the organizers of The Event, Wonderlust LLC, Spirithaven LLC and The Landowners. That this General Release of liability, Indemnification and Assumption of the Risk shall be governed and construed in accordance with the laws of the State of Virginia.

On behalf of myself, my heirs, executors, administrators and assigns, I do hereby knowingly and voluntarily assume all risk of property loss, injury or death and waive, release, discharge, and otherwise agree that I am barred from bringing any cause of action, in equity or in law, against WonderLust LLC ,Spirithaven LLC, The Landowners, officers, directors, members, employees, volunteers, representatives, or agents, for any and all claims for damages, injuries, losses, liabilities and expenses, direct, indirect or consequential, which I may have or which I may subsequently suffer, resulting from or arising out of my attendance and/or participation at The Event, even if such claim is the result of gross negligence.
